11. PUBLIC HEARINGS

A. Transmittal of Large Scale Amendment and Rezoning for Heritage Lakes

Recommendation: The applicant for the property located near the new Ellis Road/I-95 interchange has withdrawn their request for a future land use map revision and rezoning. No action is needed.

B. Code Amendment to Add Master Plan Process in the Gateway Interchange Zoning District

Recommendation: Approve the second reading and adopt Ordinance No. 2018-16 Gateway Interchange zoning district change to allow for a master plan concept process.

C. Future Land Use Map Amendment for Property on the East Side of Minton Road Located Immediately South of the U.S. Postal Facility

Recommendation: Approve the first reading of Ordinance No. 2018-17 amending the future land use map of the comprehensive plan (SSA-2018-02) to change the future land use of property on the east side of Minton Road and south of the U.S. Postal Office from Commercial (COM) to Institutional (INST).

D. Proposed Rezoning of Property on the East Side of Minton located Immediately South of the U.S. Postal Facility to P-1 (Institutional).

Recommendation: Approve the first reading of Ordinance No. 2018-18, rezoning the vacant property next to the U.S. Post Office from C-P (Commercial Parkway) to P-1 (Institutional) conditioned on the approval of the comprehensive plan amendment and a development agreement limiting the type of institutions allowed on this site.

A. Revision to Oasis Apartments Traffic Impact Fee Agreement

Recommendation: .Approve revisions to the Traffic Impact Fee Credit Agreement between the County, City of West Melbourne, and Picerne Development Corporation for the construction of a new public road to connect the north portion of Coastal Lane to John Rodes Boulevard, and authorize the Mayor to sign the agreement.

B. Amendment to Subdivision Code to Simplify Calculation of Recreation Fee and Reduce Amount of Maximum Partial Credit for Private Recreation Areas

Recommendation: Approve the first reading of Ordinance No. 2018-19, amending City Code of Ordinances Section 86-64, Dedication of Parkland or Payment of Recreation Fee, by providing a fixed fee per acre when a developer elects to pay a recreation fee in lieu of dedication of park or recreation land, reducing the maximum amount of the partial credit against the recreation fee given to developers for private recreation areas, and excluding the value of private land from the calculation of the credit.

C. Springs of Hibiscus Crossing Gated Community

Recommendation: Allow Springs at Hibiscus Crossing apartments to be a gated community.

D. Agreement with Coastal Florida Police Benevolent Association

Recommendation: Adopt Resolution No. 2018-33 amending the adopted fiscal year 2018-2019 budget by \$174,500 and approving a collective bargaining agreement with the Coastal Florida Police Benevolent Association for a term ending December 31, 2020.
