### PROJECT DESCRIPTION

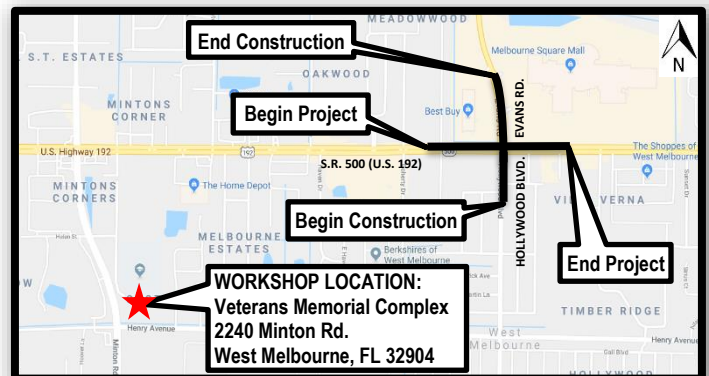
The State Road (S.R.) 500 (U.S. 192) at Hollywood Boulevard/Evans Road project consists of pavement widening to accommodate additional turn lanes along State Road 500 and Hollywood Boulevard/Evans Road. Other improvements including milling and resurfacing, replacing existing mast arms, upgrading signing and pavement markings, upgrading pedestrian features to meet Americans with Disabilities Act (ADA) requirements, and drainage and Intelligent Transportation System (ITS) improvements.
