Requirements:

A permit is required to erect, construct, enlarge, move or make structural alterations for any sign.
A separate application and a separate permit shall be required for the different types of signs at a location. (One for wall. One for detached. One for portable.)
Submit two (2) copies of scaled drawings showing elevation of building structure with proposed sign and lettering super-imposed in correct ratio.
If detached sign is over 32 square feet, or roof or projecting sign, the plans must be prepared and sealed by a registered engineer.
All detached signs shall be landscaped at the base with a minimum of two (2) square feet of landscape material for every two (2) feet of sign facial area.
Submit a plot plan diagram showing exact proposed placement of sign in relation to public right-of-ways, utility easements and property line.
Notation on drawings as to type, size and coloring of letters.
